In support of the claim for lien, Claimant states as follows:

- 1. On and before January 12, 2023 Owner owned the Property, the legal description of which is attached to the claim for lien as Exhibit A.
- 2. On January 12, 2023, Claimant and Owner entered into a contract ("Contract") under which Claimant agreed to install an automatic fire protection sprinkler system at the Property in exchange for payment by Owner of the sum of \$23,435.00.
- 3. Subsequent to January 12, 2023, at the special insistence and request of Owner, Claimant furnished extra and additional materials and labor to the Property valued at \$300.00.
- 4. On or about April 15, 2023, Owner prevented Claimant from completing its work by failing to perform Owner's obligations under the Contract.
- 5. On April 25, 2023, Claimant substantially completed all work required to be done under the Contract that it was capable of performing in the face of Owner's failure to perform. The work performed by Claimant has altered, ornamented and repaired the Property and constitutes a valuable improvement to the Property. The value of the work that Claimant performed is \$12,589.00
- 6. Owner has paid \$1,339.00 towards the amount due under the Contract, leaving due, unpaid and owing to Claimant the sum of \$11,250.00. Owner has failed and refused to pay this amount to Claimant. Hence, pursuant to 770 ILCS 60/7, Claimant hereby claim a mechanics lien upon the Property in the amount of \$11,250.00, plus interest.
