### SUBCONTRACTOR'S CLAIM FOR LIEN

The claimant, Digangi Plumbing Company, an Illinois Corporation of the Village of Mundelein, County of Lake, State of Illinois, (hereinafter "Claimant") hereby files a subcontractor's claim for lien against Alpha Construction Services, LLC, (hereinafter "Contractor") and Lake Lathrop Partners LLC (he einafter "Owner") both Contractor and Owner with the address of 1525 W Homer Street, Suite 401, Chicago, IL, 60642, and Beverly Bank & Trust Company, N.A, Oak Lawn, IL 60453 (hereinafter "Lender") and the Village of River Forest (hereinafter "Party in Interest"). River Forest 60302 and any persons claiming an interest in the premises herein and states:

1. On April 7, 2023, and subsequently, Owner owned a fee simple interest, and possibly other interests, in the Real Estate (including all land and improvements thereon) in Cook County, Illinois, commonly known as 423 Ashland and 7601-7621 Lake Street, River Forest, Illinois (hereinafter "the Project") and legally described as follows:

#### PARCEL 1:

The permanent real estate tax numbers of the Real Estate comprising the Project are 15-12-117-002-0000; 15-12-117-003-0000; 15-12-117-017-0000; 15-12-117-018-0000; and 15-12-117-019-0000.

- 2. Alpha Construction Services, LLC was the Owner's contractor, or in the alternative, Party in Interest's contractor for the improvement of the Real Estate.
- 3. On April 7, 2023, Marty Paris a/k/a Martin Paris a/k/a F. Martin Paris (hereinafter "Paris") as agent of Contractor and/or Owner provided a cetter of Intent (hereinafter "LOI") dated April 6, 2023, directing Claimant to immediately proceed with shop drawings and procurement of all long lead items, and committing to issue a subcontract to Claimant for \$692,000 for plumbing, gas line and underground plumbing work.
- 4. On April 10, 2023, Claimant and Paris agreed on the price for work to be performed and materials provided by Claimant for the Project and the start date for Claimant's onsite work. On April 12, 2023, Claimant's employees began performing plumbing work at the Project site.
- 5. On June 5, 2023, Contractor (through Paris as authorized agent) and Claimant agreed in writing on change orders, a final schedule of values and progress payments, and a partial payment. The total cost of change orders agreed to by Contractor, or alternatively the Owner, is \$6,957.00. Claimant's last date of performance at the Project site was on or around July 18, 2023.
  - 6. This claim of lien arises out of the express contract in the LOI, and the express or implied in fact contract based on the proposed contract received by Claimant from Contractor, Paris' directing, approving, or acquiescing to Claimant's performance as

agreement between Claimant and Paris, as authorized agent of Contractor and Owner, regarding change orders and progress payments, and other documents and verbal communications between Claimant and Owner, Contractor, or their authorized agents.

7. The amount due on the plumbing subcontract:

- 8. Claimant completed the work for which Claimant claims a lien on or around July 18, 2023.
- 9. As of the date of this Claim, there is due, unpaid, and owing to Claimant, after allowing all credits and contracted holdbacks, the principal sum of \$150,261.30, which principal amount bears interest at the scautory rate of 10 percent per annum. Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$150,261.30 plus interest.
- 10. Claimant revokes any waiver of rights for which Claimant has not received payment.
