ORDER OF DEFAULT AND JUDGMENT

THIS MATTER coming before the Court on Plaintiff's Motion for Entry of Order of Default and Judgment (the "Motion") filed by Plaintiff Wells Fargo Equipment Finance, Inc. ("Plaintiff") against Four Systers Transportation Inc. only ("Four Systers"); due and proper notice of the Motion having been given, and this Court being fully advised in the premises;

THIS COURT FINDS AS FOLLOWS:

- A. Plaintiff filed its Complaint (the "Complaint") in his matter on September 20, 2022.
- B. Four Systers was properly served with a copy of the Second Alie. Summons and the Complaint on January 5, 2023.
- C. No appearance or responsive pleading has been filed on behalf of Four Systers, and Four Syster's deadline to file an answer or responsive pleading has passed.
- D. As a result of Four Syster's failure to respond, all allegations included in the Complaint are confessed against Four Systers and Plaintiff is entitled to entry of a judgment against Four Systers for the relief sought in the Complaint.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

1. Judgment is entered in favor of Plaintiff, and against Four Systers, in the amount of \$44,035.46 (the "Judgment Amount") as of February 16, 2023.

- 2. On and after March 22, 2023, interest shall continue to accrue on the Judgment Amount, less any payments received from Defendants, at the rate set forth in 735 ILCS 5/2-130,3 until satisfied in full.
- 3. Four Systers, their successors and assigns, or any other person in possession of the following pieces of collateral that have not been recovered by Plaintiff, one (1) used 2016 Kenworth T680 Tractor identified by the following serial number: 1XKYDP9X8GJ481527 (the "Remaining Collateral") is/are directed to immediately turn over such Remaining Collateral to Plaintiff or its agents;
- 4. Plaintiff is entitled to immediate possession of the Remaining Collateral, including any and all additional attachments and accessories thereto;
- 5. The Sheriff or other marshal in any county where the Remaining Collateral is located is directed to take possession of the Collateral and deliver some to the officers or agents of Plaintiff without further Order of this Court;
- 6. The Cook County Sheriff's Office is hereby directed to enter all buildings, warehouses, garages, or other enclosures located at 1174 Memorial Drive, Calumet City, Illinois 60409, and open and inspect all buildings, enclosures or containers which may contain the Remaining Collateral;
- 7. Plaintiff is permitted to sell the Remaining Collateral at public or private sale or sales as permitted under the Loan Agreements and/or applicable law; and
