MEMORANDUM OF LEASE

THIS MEMORAND UM OF LEASE ("Memorandum of Lease") is executed as of July 31, 2023, by and between Forest Edge Healthcare & Rehabilitation Center Realty LLC, an Illinois limited liability company (hereinatter called the "Lessor"), and Forest River Master Tenant LLC, an Illinois limited liability company (hereinatter called the "Lessee").

RECITALS

WHEREAS, Lessor and Lessee have executed that certain Master Lease (the "Lease") dated July 31, 2023, covering certain land as more particularly described in Exhibit A attached hereto and incorporated herein by this reference (the "Premises") and improved with a nursing facility, together with Lessor's easements and appurtenants in adjoining and adjacent land, highways, roads, streets lands, whether public or private, reasonably required for the installation, maintenance, operation and service of sewer, water, gas, power and other utility lines and for day evays and approaches to and from abutting highways for the use and benefit of the above-described parcel of real estate located at 8001 S. Western Ave., Chicago, County of Cook, State of Illinois.

WHEREAS, Lessor and Lessee desire to record notice of the Lease in the public records of Cook, Illinois.

NOW THEREFORE, in consideration of the foregoing, Lessor and Lessee hereby declare as follows:

- 1. <u>Demise</u>. Lessor hereby leases the Property to Lessee and Lessee hereby leases the property from Lessor, subject to the terms, covenants and conditions contained in the Lease.
- 2. Expiration Date. The term of the Lease ("Term") commenced on July 31, 2023, and shall expire on December 31, 2057, unless sooner terminated or extended as provided in the Lease.




