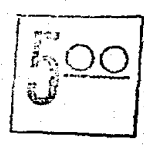

This Indenture, Made this 6th day of September 19 75,

Witnesseth. That said party of the first part, in consideration of the sum of
Ten and no/100 (\$10.00) Dollars, and other good and
valuable considerations in hand paid, does hereby grant, sell and convey unto said party of the second part,
not as tenants in common, but as joint tenants with the following real estate, situated in
Cook County, Illinois, to wit: right of survivorship.

Lot 6 in Resubdivision of Lots 9 to 19 both inclusive in Block 6 in Murray
Addition to Jefferson, being a Subdivision of the South East $\frac{1}{4}$ of the South
East $\frac{1}{4}$ of Section 9, Township 40 North, Range 13, East of the Third Principal
Meridian, (except that part taken by the Chicago, Milwaukee and St. Paul
Railroad) in Cook County, Illinois



together with the tenements and appurtenances thereunto belonging.

To Have and to Hold the same unto said party of the second part, and to the proper use, benefit and
behalf forever of said party of the second part not as tenants in common, but as joint tenants
with right of survivorship.

Subject to conditions and restrictions of record; 1975 and subsequent years
taxes.

This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said
trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above
mentioned. This deed is made subject to the lien of every trust deed or mortgage (if any there be) of record in
said county given to secure the payment of money, and
remaining unreleased at the date of the delivery hereof.

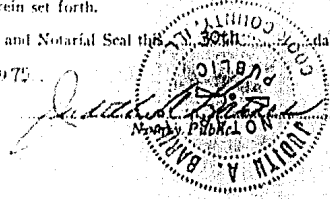
