Witnesseth, That a party of the first part in consideration of the sum of TEN AND NO/100ths Dollars, and other good and valuable considerations in hand paid, they hereby grant, sell, convey and quit-claim unto said party of the second part, the following described real estate, situated in Cook County, Illinois, to-wit:

Lots 18 to 21 (except the South 10.98 feet of said Lots) in Mandell's Subdivision of Blocks 1 to 4 inclusive, in Purington and Scranton's Subdivision of that part of the West half of the South West quarter lying North of Barry Point Road in Section 15, Township 39 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois;

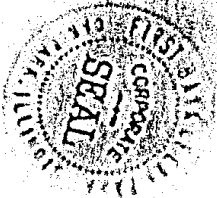
together with the tenements and appurtenances thereunto belonging To Have and to Hold the same unto said party of the second part forever.

subject to all General Taxes and Special Assessments of record, whether current, deferred, sold or otherwise, and zoning and building ordinances.

Party of the first part executes this instrument solely in its capacity as Trustee as aforesaid and not in its own individual capacity, and any individual liability on its part is hereby waived and released by the parties of the second part, their heirs, legal representatives, successors and assigns.

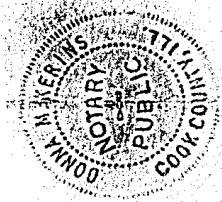
