- 3. The interest of each and every beneficiary under said Trust Agreement and hereunder, and of all persons claiming under any of the beneficiaries, shall be only in the earnings, avails and proceeds arising from the sale or other disposition of the trust property, and such interest is hereby declared to be personal property only, and the beneficiary or beneficiaries of the trust shall not have any title or interest therein, legal or equitable, except as stated.
- 4. In the event of the inability, or refusal of the Trustee herein named to act, or upon the Trustee's removal from the County, **KELLY ANN PARISO** is then appointed as Successor Trustee, with like powers and authority as are vested in the Trustee named herein.


