This Amendment to the Declaration of Condominium Ownership and By-Laws Easements, Restrictions, and Covenants For Clenview Gardens Condominium Association, is made and entered into this day of Live 2023, by the Board of Managers of Glenview Gardens Condominium Association (be enafter referred to as the "Board") and the undersigned Unit Owners of condominium units in Glenview Gardens Condominium Association (hereinafter referred to as "Unit Owners"), being at least t'tree-fourths (3/4) of the Unit Owners of Glenview Gardens Condominium Association.

WITNESSETH

WHEREAS; by a certain Declaration of Condon injum Ownership and By-Laws; Easements, Restrictions and Covenants for Glenview Gardene Condominium Association recorded in the Office of the Recorder of Deeds of Cook County, Alicois, as Document No. 95165318 (hereinafter called "Declaration"), certain real estate located in Glenview Cook County, Illinois (hereinafter called "Property") identified therein was submitted to the Condominium Property Act of the State of Illinois (hereinafter called "Act"). The real estate now subject to the Declaration is identified and legally described in Exhibit "A" which is attached herein and forms a part hereof; and

WHEREAS, for purposes limiting the number of Units that are leased and to encourage owner occupancy of Units, the Unit Owners deem it desirable to modify and amend the Declaration to provide that a unit may not be leased until a Unit Owner has been the owner of occupied and resided in the Unit as the Owner's primary residence for a period of one full year after becoming the owner of the Unit; and to further clarify that allowing use of Units through short term rental services such as Airbnb is considered a prohibited transient and hotel purpose; and

WHEREAS, Article XIX, Section 6(b) of the Declaration provides that the provisions of the Declaration may be Amended, changed, or modified by an instrument in writing setting forth such amendment, change or modification, signed and acknowledged by all of the members of the Board and at least three-fourths (3/4) of the Unit Owners, and containing an affidavit by an officer of the Board certifying that a copy of the amendment, change or modification has been mailed by certified mail to all mortgagees having bonafide lines of record against any Unit, not less than ten (10) days prior to the date of such affidavit;

NOW THEREFORE, the Board and Unit Owners being at least three-fourths (3/4) of the Unit Owners do further hereby amend and modify the Declaration as follows:

1. The Declaration, Article XVII, entitled "Covenants and Restrictions As To Use and Occupancy," at Section 15 entitled "Lease of Units," is hereby amended and modified by adding the following to Section 15:

Upon a sale or traisful of a Unit to a new owner, the Unit may not be leased or licensed to any person pursuant to this Section 15 unless and until the new Unit Owner has occupied and resided in the Unit as the Unit Owner's primary residence for a period of (1) full year. After the Unit Owner has resided in the Unit for one full year the Unit is eligible to be leased, subject to all provisions of this Declaration and By-Laws. Units shall not leased, licensed, rented, or occupied through the use of Airbnb, VRBO, or any similar service, at any time.

This Amendment To Declaration of Condonar aum Ownership And By-Laws, Easements, Restrictions and Covenants for Glenview Gardens Condonar aum Association shall become effective on the date it is filed with the Recorder of Deeds of Cook County, Illinois.
