Lot 5 in Block 42 in The Trails Unit Three, being a subdivision of the Southwest 1/4 of Section 35, Township 41 North, Range 10 East of the Third Principal Meridian, as per plat of Subdivision recorded January 4, 1973, as Document No. 22176580 and Surveyor's Certificate of Correction recorded April 17, 1975 as Document No. 23053033, in Cook County, Illinois.
