RELEASE OF REDEV'LLOPMENT AGREEMENT

THIS RELEASE OF REDEVELOPMENT A GREEMENT is executed on or as of the 30 day of 2023, by the CITY OF CHICAGO, an Illinois municipal corporation and home rule unit of government (the "City"), having its principal offices at 121 North LaSalle Street, Chicago, Illinois 60602, acting by and through its Department of Housing ("DOH").

St. Bernard-PBI Housing, LLC, an Illinois limited liability corporation (the "Developer"), and the City entered into that certain Redevelopment Agreement – New Homes for Chicago Program, St. Bernard-PBI Housing, LLC (the "Agreement"), dated as of April 1, 2008, and recorded April 4, 2008, as document number 0809534096 with the Cook County Clerk's Office, in relation to the City's New Homes for Chicago Program. The Agreement encombered several parcels of land owned by the City and the Developer (together the "City Lots" and "Private Lots"), including the parcels legally described on Exhibit A attached hereto and made a part hereof (such City Lots and Private Lots legally described in Exhibit A, the "Property"). The City has not conveyed, is not obligated to convey (see Section 3.2 of the Agreement), and shall not convey the City Lots to the Developer.

NOW THEREFORE, the City hereby releases the Agreement from the Property and the Agreement shall be of no further force and effect with respect to the Property.
