THIS INDENTURE made October 6th 1975, between

State of Illinois herein referred to as "Mortgagors" and Avenue Bank and Trust Company of Oak Park an Illinois

THAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the Instalment Note here-
inafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of
SEVENTY FIVE THOUSAND AND 00/100ths (\$75,000.00) Dollars,
evidenced by one certain Instalment Note of the Mortgagors of even date herewith, made payable to BEARER

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest from the date hereof on the balance of principal remaining from time to time unpaid at the rate of $\frac{1}{2} \text{ per cent per annum}$ in instalments as follows:

8-3/4% per cent per annum in interest, amounts as follows:
Six Hundred Sixty Two and 79/100ths (\$662.79) --
Dollars or more on the 15th day of May 1976 and

Dollars or more on the 15th day of each month thereafter
SIX HUNDRED SIXTY TWO and 79/100ths (\$662.79) -
Dollars or more on the 15th day of each month thereafter
until said note is fully paid except that the final payment of principal and interest, if not sooner paid, shall be
due on the 15th day of April 1996. All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder
to principal; provided that the principal of each instalment unless paid when due shall bear interest at the rate
of 9-1/2% per annum, and all of said principal and interest being made payable at such banking house
or trust company as the holders of the note may, from time to time, in writing appoint, and in absence of such
appointment at the office of Avenue Bank and Trust Company of Oak Park, Oak Park, Illinois.
