QUIT CLAIM

THIS INDENTURE WITNESSETH, That the Grantor, Rita L. Slimm, a Spinster, - - -
of the County of Cook and State of Illinois for and in consideration

and valuable considerations in hand paid, Conveys and Quit Claim s unto
BANK OF RAVENSWOOD, an Illinois banking corporation, 1825 W. Lawrence Avenue, Chicago,
Illinois 60640, its successor or successors, as Trustee under a trust agreement dated the day of
August 22, 1975 known as Trust Number 1614, the
following described real estate in the County of Cook and State of Illinois, to wit:

Lots 17 and 18 in Block 10 in Ravenswood, being a Subdivision of part of the North East 1/4 of Section 18, Township 40 North, Range 14, East of the Third Principal Meridian, except the North 1/2 of the North East 1/4 of that part of Section 17, Township 40 North, Range 14, East of the Third Principal Meridian in Cook County, Illinois.

TO HAVE AND TO HOLD the real estate with its appurtenances from the Trustee and for the uses and purposes herein and in the trust agreement set forth:

fully vested with all the title, estate rights, powers, authorities, duties, and obligations of its holder from predecessor in title.

The interest of each beneficiary under the trust agreement and of all persons claiming under them or any of them shall be only in the property so held, and no power, right, or interest in any property or other disposition of the real property, such interest being limited to the specific property and beneficiaries. It shall have no title or interest, legal or equitable, in or to the real property itself, but only an interest in the possessory earnings, assets and proceeds thereof as aforesaid.

If the title to any or all of the above lands is now or hereafter registered, the Register of Titles shall be directly notified to register the same in the name of or under the name of the individual or corporation whose name is in the "trust" or "trustee" column or with limitations, or words of similar import, as the case may be, and the name of the person or persons holding the title or interest in the above lands.

And thus each creature, though apparently weak, yet triumphs over its enemies, and in safety and security, in accordance with the statutes in such case made and provided.

And the said grantee hereby expressly waives, and releases, any and all right of action under and by virtue of any and all
statutes of the State of Illinois, pertaining for the exemption of homesteads from sale or execution of otherwise.
