and to his successors in trust by him or her named, for the purpose of securing performance of the covenants and agreements
herein, the following described real estate, with the improvements thereon, including all heating, gas and plumbing app-
aratus and fixtures, and everything appertaining thereto, together with all rents, issues and profits of said premises, situated
in the City of Chicago County of Cook and State of Illinois, as set

Let 21 in Block 19 in Irving Park Addition, a Subdivision of Lots 2 to 6 inclusive and 16 to 20 inclusive and part of Lot 21 in Fitch and Hecox Sub-division of the NE 1/4 of Section 15, Township 40 North, Range 13, East of the Third Principal Meridian.

Herby releasing and waiving all rights under and by virtue of the homestead and option laws of the State of Illinois,
in TRUST, nevertheless, for the purpose of securing performance of the above acts and agreements herein.

WHEREAS, The Grantor, a. EDWARD R. PASTIVO and ROSEMARIE PASTIVO, his wife,

justly indebted upon their one principal promissory note bearing even date herewith, payable
NORTHWEST NATIONAL BANK OF CHICAGO, for the sum of FIFTY three hundred sixty four and 60/100 Dollars (\$5364.60) payable in 59 successive monthly instalments each of \$89.41 except the final instalment which shall be equal to or less than the monthly instalments due on the note commencing on the 21st day of November 1978, and on the same date of each month thereafter, until paid, with interest after maturity at the highest lawful rate.

In view of the fact that the above-mentioned expenses have been incurred by the members of the Committee, it is requested that the same be reimbursed to the Committee by the Government of India.
