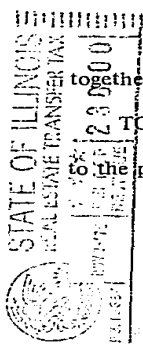

 to the proper use, benefit and behoof of said party of the second part forever.

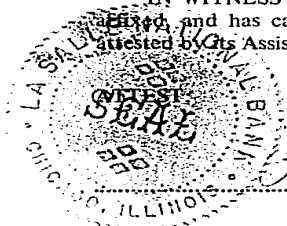
