FINAL JUDGMENT ORDER

8001

This cause coming to be heard on the Complain. For Condemnation filed by The Department of Transportation of the State of Illinois ("Depar ment") to acquire a temporary easement for construction purposes in the real property designated in the Complaint as Parcel OMR0009TE and to ascertain the just compensation to be paid for this acquisition, and the Court having been duly advised in the premises;

THE COURT HEREBY FINDS:

- The Department is represented by Kwame Raoul, Attorney General of the State of Illinois, by James R. Carr, Special Assistant Attorney General, Carr Law Firm LLC, 2250
 W. Belmont Avenue, Unit 4W, Chicago, Illinois.
- 2. On November 14, 2022, the Department filed a Complaint For Condemnation ("Complaint") to acquire a temporary easement for construction purposes for a period not to

exceed five (5) years from the date of vesting of title, or until completion of construction, whichever first occurs, across and upon the parcel of real property designated in the Complaint as Parcel 0MR0009TE, as legally described in Exhibit A hereto.

- 3. On November 14, 2022, the defendant, CPP PROPERTIES MATTESON LLC, an Illinois Limited Liability Company, owned fee simple title to the Whole Property, including but not limited to Parcel OMR0009TE.
- 4. All defendants have been served with process, and the Court has jurisdiction over the subject matter of this proceeding and all parties.
- 5. The defendants, CPP PROPERTIES MATTESON LLC, an Illinois Limited Liability Company, PACIFIC I ARADIGM, INC., or Its Successors or Assigns By Reason of Document 1128022088, and OLD NATIONAL BANK, Successor to First Midwest Bank, have not appeared in this action.
- 6. On March 28, 2023, this Court entered 2 judgment of default against all three of the aforesaid defendants pursuant to 735 ILCS 5/2-1301(c).
- 7. On March 28, 2023, the Court also entered a judgment of default against the defendant Unknown Owners and Non-Record Claimants.
- 8. Parcel 0MR0009TE is part of a larger parcel (the "Whole Property") measuring approximately 65,863 square feet (1.512 acres) which is located at the southwest corner of US Route 30 (Lincoln Highway) and Lindenwood Drive. The common address of the Whole Property is 4605 Lincoln Highway, Matteson, Illinois.
- 9. Pursuant to the Department's Motion for Immediate Vesting of Title, this Court entered an order on February 22, 2022 determining the preliminary just compensation for the

taking of the temporary easement across and upon Parcel 0MR0009TE in the amount of twelve thousand four hundred dollars (\$12,400.00).

- 10. The award of preliminary just compensation was entered following an ex parte prove-up hearing and was based upon the Affidavits of Lin M. Li, P.E., one of the Department's Land Acquisition Engineers, and Dino Lanzo, Civiltech Engineering, Inc., a Certifico General Real Estate Appraiser, who appraised Parcel 0MR0009TE at \$12,400.00 as of the valuation date, November 14, 2022, when the Complaint was filed.
- 11. The Department deposited the preliminary just compensation of \$12,400.00 with the Cook County Treasurer on March 23, 2023.
- 12. On March 28, 2023, the Court entered an Order Vesting Title to a temporary easement for construction purposes for a region not to exceed five (5) years from the date of vesting to title, or until completion of construction, whichever first occurs, on the parcel of real property designated in the Complaint as Parcel OMR 6009TE and authorizing the Department to take possession of Parcel OMR 0009TE and exercise all property rights vested in the Department therein.
- 13. On June 27, 2023, the defendant, COOK COUNTY TREASURER, appeared in this action and is represented by Ares G. Dalianis, Esq. and Jared M. Costanz of Franczek P.C., 300 S. Wacker Drive, Suite 3400, Chicago, Illinois.
- 14. The full and final just compensation for the taking of a temporary easement for construction purposes in Parcel 0MR0009TE, including compensation for the property rights being taken and for any or all damage to the remainder, including costs to cure, whether claimed or unclaimed, arising out of the taking is TWELVE THOUSAND FOUR HUNDRED DOLLARS (\$12,400.00).

- 15. The Department, having previously deposited the full and final just compensation with the Cook County Treasurer, as set forth above, is entitled to a Satisfaction and Release of Judgment upon entry of this Final Judgment Order.
- 16. Defendants, CPP PROPERTIES MATTESON LLC, an Illinois Limited

 Liability Company, PACIFIC PARADIGM, INC., or Its Successors or Assigns By Reason of

 Document 1128022088, and OLD NATIONAL BANK, Successor to First Midwest Bank,

 have waived an 'claim for interest or costs, statutory or otherwise by their failure to appear or

 otherwise plead.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

- A. The full and find just compensation, including compensation for the property rights being taken and for any or all canage to the remainder, including costs to cure, whether claimed or unclaimed, arising out of the taking is TWELVE THOUSAND FOUR HUNDRED DOLLARS (\$12,400.00).
- B. This Final Judgment Order is hereby declared satisfied, and the Judgment entered herein against the Department is hereby released.
- C. The Order Vesting Title entered herein on March 28, 2023 is confirmed in all respects.
- D. This Final Judgment Order is a final judgment, and there is no just reason for delaying enforcement or appeal of this order.
- E. The Court retains jurisdiction to enforce the terms of this Final Judgment

 Order; approve disbursement of funds on deposit withs the Cook County Treasurer; and any
 other related matters.
 - F. The legal description of Parcel 0MR0009TE is set forth as Exhibit A below:
