THIS INDENTURE, made this 10th day of September, 1975, between THE DROVERS NATIONAL BANK OF CHICAGO, National banking association (successor by merger to Drovers Trust and Savings Bank), Trustee under the provisions of a deed or deeds in trust, duly recorded and delivered in pursuance of a trust agreement dated the 8th day of December, 1965 and known as Trust No. 65305...

WITNESSETH, that said party of the first part, in consideration of the sum of \$100,000.00, does hereby Quit Claim and convey unto said parties of the second part, JOYCE A. TERAHN in common with AL JOINT TENANTS, the following described real estate, situated in Cook County, Illinois to-wit:

Lot 8 in Block 2, in Williams E. Harmon Beverly Hill Addition being a subdivision of Block 1 Lot 5 and 6 in Block 2 in Tracy Heights a subdivision of the North West 1/4 of the South West 1/4 of Section 7, Township 37 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

Together with the easements and appurtenances thereto belonging, TO HAVE AND TO HOLD the same unto said parties of the second part, JOYCE A. TERAHN in common with AL JOINT TENANTS, and to the proper use, benefit and behoof forever of said party of the second part.

Subject to General Taxes for 1975.

This deed is executed by the trustee of the trust in pursuance of the power and authority granted to said trustee by the terms of said trust agreement and the provisions of said Trust Agreement, and in full satisfaction of the obligations of said Trust Agreement.
