## TRUSTEE'S DEED IN TRUST (ILLINOIS)

This agreement made this 23<sup>RD</sup> day OCTOBER, 2023, between **PAT DONATO, Trustee under the Declaration of Trust of PAT DONATO, dated February 11, 2003, Grantor and PAT DONATO, Trustee under the Restatement of Declaration of Trust of PAT DONATO, dated OCTOBER 23, 2023**, of 8231 N. Balmoral Avenue, Chicago, Illinois 60656, Grantee.

WITNESSETH: The Grantor in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00) and other good and valuable considerations receipt whereof is hereby acknowledged, and in pursuance of the power and authority vested in the Grantor as said Trustee and of every other power and authority the Grantor hereunto enabling, hereby conveys and quit claims unto the Grantee in fee simple, the following:

**THAT PART OF THE NORTH 1/2 OF NORTH WEST FRACTIONAL 1/4 OF SECTION 22, TOWNSHIP 40 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN LYING EAST OF WISCONSIN CENTRAL RAILROAD IN COOK COUNTY, ILLINOIS DESCRIBED AS FOLLOWS: COMMENCING ON A LINE WHICH IS 50.0 FEET (MEASURED AT RIGHT ANGLES) FROM NORTH LINE OF NORTH 1/2 OF NORTH WEST FRACTIONAL 1/4 OF SAID SECTION 22 AND 293.35 FEET EAST OF ITS INTERSECTION WITH EASTERLY RIGHT OF WAY LINE OF SAID WISCONSIN CENTRAL RAILROAD THENCE SOUTHEASTERLY ON A LINE PARALLEL WITH AND 285.60 FEET (MEASURED AT RIGHT ANGLES) FROM EASTERLY RIGHT OF WAY LINE OF SAID WISCONSIN CENTRAL RAILROAD A DISTANCE OF 69.06 FEET; THENCE EAST ON A LINE PARALLEL WITH THE NORTH LINE OF THE NORTH 1/2 OF NORTH WEST FRACTIONAL 1/4 SAID SECTION 22, A DISTANCE OF 131.19 FEET; THENCE NORTHWESTERLY A DISTANCE OF 69.06 FEET TO THE INTERSECTION WITH A POINT ON SAID LINE WHICH IS 50.0 FEET SOUTH OF THE NORTH LINE OF NORTH 1/2 OF NORTH WEST FRACTIONAL 1/4 OF SAID SECTION 22 AND 131.19 FEET EAST OF THE POINT OF BEGINNING THENCE WEST 131.19 FEET TO THE POINT OF BEGINNING IN COOK COUNTY, ILLINOIS.**

TO HAVE AND TO HOLD said real estate and appurtenances thereto upon the trusts set forth in said Trust Agreement and of the following uses:

1. The Trustee (or Trustees, as the case may be), is invested with the following powers: (a) to manage, improve, divide or subdivide the trust property or any part thereof, (b) To sell on any terms, grant options to purchase, contract to sell, to convey with or without consideration, to convey to a successor or successors in trust,

any or all of the title and estate of the trust, and grant to such successor or successors in trust all the powers vested in the Trustee. (c) To mortgage, encumber or otherwise transfer the trust property, or any interest therein, as security for advances or loans. (d) To dedicate parks, streets, highways, or alleys, and to vacate any portion of the premises. (e) To lease and enter into leases for the whole or part of the premises, from time to time, but any such leasehold or renewal shall not exceed a single term of 199 years, and to renew, extend or modify any existing lease.

2. Any party dealing with the Trustee with regard to the trust property, whether by contract, sale, mortgage, lease or otherwise, shall not be required to see to the application of the purchase money, loan proceeds, rental or other consideration given, nor shall be required to see that the terms of the trust have been complied with, or to inquire into the powers and authority of the Trustee, and the execution of every contract, option, deal, mortgage or other instrument dealing with the trust property, shall be conclusive evidence in favor of every person relying upon or claiming under such conveyance or other instrument, that at the time of the execution and delivery of any of the aforesaid instruments, the Trust Agreement above described was in full force and effect; that said instrument executed was pursuant to and in accordance with the authority granted the Trustee, and is binding upon the beneficiary or beneficiaries under said Trust Agreement; and if said instrument is executed by a successor or successors in trust, that he or they were duly appointed and are fully invested into the title, estate, rights, powers and duties of the preceding Trustee.

3. The interest of each and every beneficiary under said Trust Agreement and hereunder, and of all person claiming under any of the beneficiaries, shall be only in the earnings, avails and proceeds arising from the sale or other disposition of the trust property and such interest is hereby declared to be personal property only, and the beneficiary or beneficiaries of the trust shall not have any title or interest therein, legal or equitable, except as stated.

All of the covenants, conditions, powers, rights and duties vested hereby, in the respective parties, shall inure to and be binding upon their heirs, legal representatives and assigns.

If the title to any of the above real estate now is or hereafter shall be registered, the Registrar of Titles is directed not to register or note the Certificate of Title, duplicate thereof, or memorial, the words, "in trust" or "upon condition", or "with limitation" or words of similar import, in compliance with the statute of the State of Illinois in such case made and provided.

The Grantor hereby waives and releases any and all right and benefit under and by virtue of the Statutes of the State of Illinois providing for the exemption of homestead from sale or execution or otherwise.

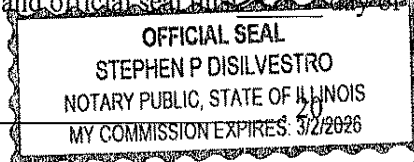

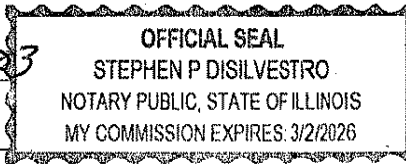

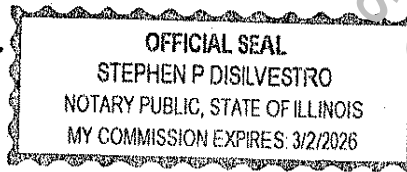
