Terms not otherwise defined in this Assignment shall have the meanings attributed to such terms in the Uniform Commercial Code. All references to dollar amounts shall mean amounts in lawful money of the United States of America.

Assignment. The word "Assignment" means this Assignment of Rents between Grantor and Lender, and includes without limitation all assignments and security interest provisions relation to the Rents.

Borrower. Michael Pasieka (known as "Borrower")

Event of Default. The words "Event of Default" mean and include without limitation any of the Events of Default set forth below in the section titled "Events of Default."

Grantor. The word 'Grantor' means any and all persons and entities executing this Assignment, including without limitation all Grantors named above. Any Grantor who signs this Assignment, but does not sign the Mortgage Note, is signing this Assignment only to grant and convey that Grantor's interest in the Real Property and to grant a security interest in the Rents and Personal Property to Lender and is not personally liable under the Mortgage Note except as otherwise provided by contract or law.

Indebtedness. The word 'indebtedness' means all principal and interest payable under the Mortgage Note and any amounts expended or advanced by Lender to discharge obligations of Grantor or expenses incurred by Lender to enforce obligations of Grantor under this Assignment, together with interest on such amounts as provided in this Assignment.

Lender. The word 'Lender' means Co nmorcial Credit Corp. successors and/or assigns.

Mortgage Note. The word "Mortgage Note" means the promissory Mortgage Note or credit agreement dated November 1, 2023 in the original principal amount of Forty-Four Thousand Eight Hundred Dollars and 00/100 (§ 44,300) from Borrower to Lender, together with all renewals of, extensions of, modifications of, refinancing of, consolidations of, and substitutions for the promissory Mortgage Note or agreement. The interest rate on the Mortgage Note is 16%.

Property. The word "Property" means the real property, and all improvements thereon, described about in the "Assignment" section.

Real Property. The words "Real Property" mean the property, interests and right described above in the "Assignment" section.

Related Documents. The words "Related Documents" mean and include without limitation all promissory Mortgage Notes, credit agreements, loan agreements, environmental agreements and documents, whether now or hereafter existing, executed in connection with the indebtedness.

Rents. The word "Rents" means all rents, revenues, income, issues, profits and proceeds from the Property, whether due now or later, including without limitation all Rents from all leases described on any exhibit attached to this Assignment.

THIS ASSIGNMENT IS GIVEN TO SECURE {1} PAYMENT OF THE INDEBTEDNESS AND {2} PERFORMANCE OF ANY AND ALL ABLIGATIONS OF GRANTOR AND BORROWER UNDER THE MORTGAGE NOTE, THIS ASSIGNMENT, AND THE RELATED DOCUMENTS. THIS ASSIGNMENT IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:

GRANTOR'S WAIVERS. Grantor waives all rights or defenses arising by reason of any "one action" or "anti-deficiency" law, or any other law which may prevent Lender from bringing any action against Grantor, including a claim for deficiency to the extent lender is otherwise entitled to a claim for deficiency, before or after Lender's commencement or completion or any foreclosure action, either judicially or by exercise or a power of sale.

GRANTEX'S REPRESENTATIONS AND WARRANTIES. Grantor warrants that:
(a) this Assignment is executed at Borrower's request and not at the request of Lender;
(b) Grantor has the full power, right, and authority to enter into this Assignment and to hypothecate the Property; (c) the provisions of this Assignment do not conflict with, or result in a default under any agreement or order applicable to Grantor; (d) Grantor has established adequate mean of obtaining from Borrower on a continuing basis information about Borrower's fir ancial condition; and (e) Lender has made no representation to Grantor about Forcewer (including without limitation the creditworthiness of Borrower).

BORROWER'S WAIVERS AND RESPONSIBILITIES. Lender need not tell Borrower about any action or inaction Lender takes in connection with this Assignment. Borrower waives any defenses that they arise because of any action or inaction of Lender, including without limitation any ellure of Lender to realize upon the Property, or any delay by Lender in realizing upon the Property. Borrower agrees to remain liable under the Mortgage Note with Lender no matter what Lender takes or fails to take under this Assignment.

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Assignment or any Related Document, Grantor shall pay to Lender all a nounts secured by this Assignment as they become due, and shall strictly perform all of Grantor's obligations under this Assignment. Unless and until Lender exercises its right of collect the Rents as provided below and so long as there is no default under this Assignment, Grantor may remain in-possession and control of and operate and manage the Property and collect the Rents, provided that the granting of the right to collect the Rents shall not constitute Lender's consent to the use of cash collateral in a bankruptcy proceeding.

GRANTOR'S REPRESENTATIONS AND WARRANTIES WITH RESPECT TO THE RENTS. With respect to the Rents, Grantor represents and warrants to Lender that:

Ownership. Grantor is entitled to receive the Rents free and clear of all rights, loans, liens, encumbrances, and claims except as disclosed to and accepted by Lender in writing.

Right to Assign. Grantor has the full right, power, and authority to enter into this Assignment and to assign and convey the Rents to Lender. **No Prior Assignment.** Grantor has not previously assigned or conveyed the Rents to any other person by any instrument now in force. No Further Transfer. Grantor will not sell, assign, encumber, or otherwise dispose of any of Grantor's

LENDER'S RIGHT TO COLLECT RENTS. Lender shall have the right at any time, upon default under this Assignment, the Mortgage or Mortgage Note, to collect and receive the Rents. For this purpose, Lender is hereby given and granted the following rights, powers and authority:

rights in the Rents except as provided in this Agreement.

Notice to Tenants. Lender may send notices to any and all tenants of the Property advising them of this Assignment and directing all Rents to be paid directly to Lender or Lender's agent.

Enter the Property. Lender may enter upon and take possession of the Property; demand, collect and receive from the tenants or from any other persons liable there ore, all of the Rents; institute and carry on all legal proceedings necessary for the protection of the Property, including such proceedings as may be necessary to recover possession of the Property; collect the Rents and remove any terrant or tenants or other persons from the Property.

Maintain the Property. Lender may enter upon the Property to maintain the Property and keep the same in repair; o pay the costs thereof and of all service of all employees, including their equipment, and of all continuing costs and expenses of maintaining the Property in proper repair and condition, and also to pay all taxes, assessments and water utilities, and the premiums on fire and other insurance effected by Lender on the Property.

Compliance with Laws. Lender may enter upon the Property to maintain the Property and keep the same in repair; to pay the costs thereof and of maintaining the Property in proper repair and condition and also to pay all taxes, assessments and water utilities, and the premiums on fire and other preparate effected by Lender on the Property.

Lease the Property. Lender may rent or lease the whole or any part of the Property for such term or terms and on such conditions as Lender may deem appropriate.

applied to the Indebterlness. All expenditures made by Lender under this Assignment and not reimbursed from the Rents shall become a part of the Indebtedness secured by this Assignment, and shall be payable on demand, with interest and the Mortgage Note rate from date of expenditure until paid.

FULL PERFORMANCE. IT Grantor pays all of the Indebtedness when due and otherwise performs all the obligations imposed upon Grantor under this Assignment, the Mortgage Note, and the Related Documents. Lender shall execute and deliver to Grantor a suitable satisfaction of this Assignment and suitable statements of termination of any financing statement on file evidencing Lender's security interest in the Rents and the Property. Any termination fee required by law shall be paid by Grantor, if permitted by applicable law. If, however, payment is made by Borrower, whether voluntarily or otherwise, or by guarantor or by applicable law. Any amount that Lender expends in so doing will bear interest at the rate provided for in the Mortgage Note from the date incurred or paid by Lender to the date of repayment by Grantor. All such expenses, at Lender's

option, will (a) be payable on demand, (b) be added to the balance of the Mortgage Note and be apportioned among and be payable with any installment payments to become due during either (1) the term of any applicable insurance policy or (2) the remaining term of the Mortgage Note, or (c) be treated as a balloon payment which will be due and payable at the Mortgage Note's maturity. This Assignment also will secure payment of these amounts. The rights provided for in this paragraph shall be in addition to any other rights or any remedies to which Lender may be entitled on account of the default. Any such action by Lender shall not be construed as curing the default so as to bar Lender from any remedy that it otherwise would have had.

DEFAULT. Each of the following, at the option of Lender, shall constitute an event of default (Fivent of Default") under this Assignment:

Default on Antichtedness. Failure to make any payment when due on the indebtedness.

Compliance Default. Failure of Grantor or Borrower to comply with any other term, obligation, covenant or condition contained in this Assignment, the Mortgage Note or in any of the Related Decuments.

Default in Favor of Third Parties. Should Borrower or any Grantor default under any loan, extension of credit, security agreement, purchase or sales agreement, or any other agreement, in favor of any other creditor or person that may materially affect any of Borrower's property or Borrower's or any Grantor's ability to repay the Loans or perform their respective obligations under in: Assignment or any of the Related Documents.

False Statements. Any warranty, representation or statement made or furnished to Lender by or on behalf of material respect, either now or at the time made or furnished.

Defective Collateralization. This Assignment or any of the Related Documents ceases to be in full force and effect (including failure of any collateral documents to create a valid and perfected security interest or lien) at any time and for any reason.

Other Defaults. Failure of Grantor or Borrower to comply with any term, configution, covenant, or condition contained in any other agreement between Grantor or Porrower or Lender.

Death or Insolvency. The death of Grantor or borrower or the dissolution or termination of Grantor or Borrower's existence as a going business, the insolvency of Grantor or Borrower, the appointment of a receiver for any part of Grantor or Borrower's property, any assignment for the benefit of creditors, any type of creditor workout, or the commencement of any proceeding under any bankruptcy or insolvency laws by or against Grantor or Borrower.

Foreclosure, Forfeiture, etc. Commencement of foreclosure or forfeiture proceedings, whether by judicial proceeding, self-help, repossession or any other method, by any creditor of Grantor or by any governmental agency against any of the Property.

Adverse Change. A material adverse change occurs in Borrower's financial condition, or Let der believes the prospect of payment or performance of the indebtedness is impaired

Insecurity. Londer reasonably deems itself insecure.

RIGHTS and REMEDIUS ON DEFAULT. Upon the occurrence of any Event of Default and at any time thereafter, Leader may exercise any one or more of the following rights and remedies, in addition to any outer rights or remedies provided by law:

Accelerate Indebtedness. Lender shall have the rights at its option without notice to Borrower to declare the entire in telephones immediately due and payable, including any prepayment penalty which Borrower would be required to pay.

Collect Rents. Lender shall have the right, without notice to Grantor or Borrower, to take possession for the about Lender's costs, uprinst the indebtedness, In furtherance of this right, Lender shall have all the rights provided for in the Lender's Right to Collect section, above. If the Rents are collected by Lender, then Grantor irrevocably designates Lender as Grantor's attorney-in-fact to endor e in struments received in tenants or other users to Lender in response to Lender's aemand shall satisfy the obligations for which payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subpact graph either in person, by agent, or through a receiver.

Mortgagee in Possession. Lender shall have the rights to be placed as mortgagee in possession or to have a receiver appointed to take possession of all or any part of the Property, with the power to protect and preserve and apply the proceeds, over and above the proceeds, over and above the cost of the receivership, against the indebtedness. Applicable Law. This Assignment has been delivered to Lender and accepted by Lender in the State of Illinois. This Assignment shall be governed by an I construed in accordance with the laws of the State of Illinois.

Multiple Parties. All obligations of Grantor and Borrower under this Assignment shall be-joint-and several, and all-references to Grantor shall mean each and every-Grantor, and all references to Borrower shall mean each and every Borrower. This means that each of the persons signing below is responsible for all obligations in this Assignment.

No Modification. Grantor shall not enter into any agreement with the holder of any mortgage, deed of trust, or other security agreement which has priority over this Assignment by which that agreement is modified, amended, extended, or renewed without the prior written consent of Lender. Grantor shall neither request nor accept any future advances under any such security agreement without the prior written consent of Lender.

Severability. If a court of competent Jurisdiction finds any provision of this Assignment to be invalid or unenforceable as to any person or circumstance, such finding shall not render that provision invalid or unenforceable as to any other persons or circumstances. If feasible, any such offending provision shall be deemed to be modified to be within the limits of enforceability or validity; however, if the offending provision cannot be so modified, it shall be modified, it shall be stricken and all other provisions of this Assignment in all other respects shall remain valid and enforceable.

Successors and Assigns. Subject to the limitations stated in this Assignment on transfer of Grantor's interest, this Assignment shall be binding upon and inure to the benefit of the parties, their successors and to Grantor, may deal with Grantor's successors with reference to this Assignment and the indebtedness by way of forbeatance or extension without releasing Grantor from the obligations of this Assignment or liability under the indebtedness.

Not with standing any of the provisions to the contrary contained in this Assignment, Granter hereby waives any and all rights of redemption from sale under any order or judg neat of foreclosure on behalf of Grantor, Acquiring any interest in or Title to the property suo equent to the date of this Assignment.

Waivers and Consents. Lender shall not be deemed to have waived any rights under this Assignment (or under the Related Documents) unless such waiver is in writing and in and signed by Lender. No delay or omission on the part of Lenier in exercising any right shall operate as a waiver of such right or any other right. A waiver by any party of a provision of this Assignment shall not constitute a waiver of or prejudice the party's right otherwise to demand strict compliance with that provision of any other provision. No prior waiver by Lender, nor any course of dealing between Lender and Grantor or Borrower's obligations as to any future transactions. Whenever conservely—Lender is required in this Assignment, the granting of such consent by Lender in any instance shall not constitute continuing consent to subsequent instances where such consent is required.
