7. Remedies.

- (a) Notice of Default. Lender will give a notice of default to Borrower following Borrower's breach of any occrement or agreement in this Security Instrument. The notice will specify, in addition to any information required by applicable law: (i) the default; (ii) the action required to cure the default; (iii) that failure to cure the default on or before the date specified in the notice may result in foreclosure by judicial proceeding and sale of the Property; and (iv) Borrower's right to deny in the foreclosure proceeding the existence of a default or to assert any other defense of Borrower to foreclosure.
- (b) Foreclosure; Expenses.
