Morgan Chase Commercial Mortgage Securities Corp. The Owner is entitled to credits on account thereof as follows: payments in the amount of \$102,377.25, leaving due, unpaid, and owing to the Claimant, after allowing all credits, the sum of \$35,733.75, for which, with interest, the Claimant claims a lien on the Property and on the moneys or other consideration due or to become due under the Contract, against the Owner and the Lender Lienholders.
