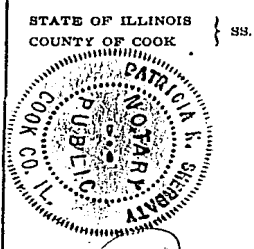
Subject to: Covenants, conditions, restrictions and easements of record and general real estate taxes for the year 1974 and subsequent years.
