11. That the heirs at law to Jorge Estrada Martinez, is Giovanni Paulo Estrada Adame, his son.

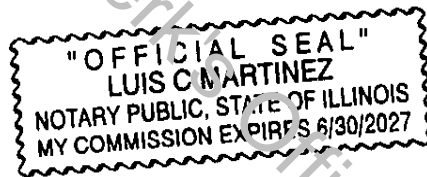
