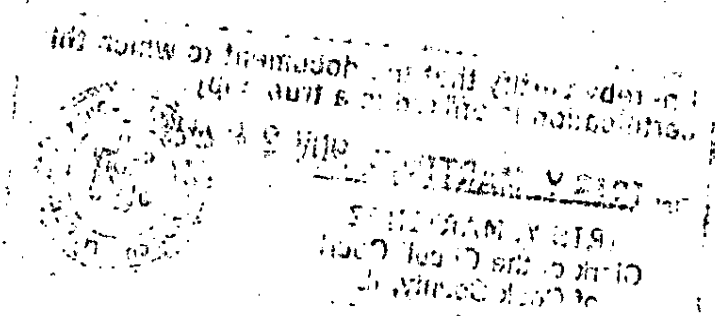
AGREED ORDER

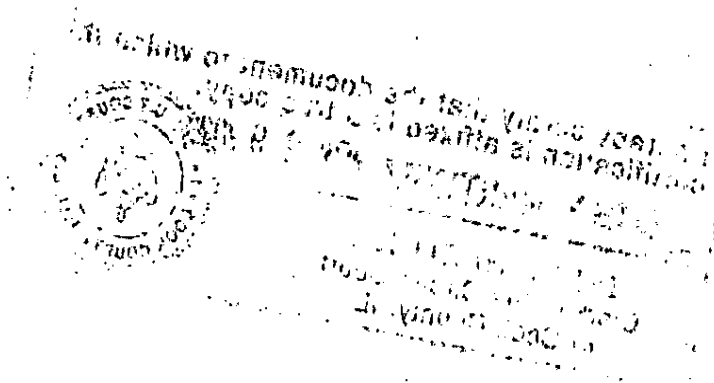
