AGREED JUDGMENT ORDER

This matter comes celo e the Court, counsel for Plaintiff, Harold O. Schulz Company, Inc. and counsel for Defendant, Cree y Sala Investments, LLC d/b/a D&D Natural Stone Works, Inc., being present, due notice given, and the Court being fully advised of the premises, IT IS HEREBY ORDERED THAT:

- 1. Creevy Bala Investments, LLC L'b/a D&D Natural Stone Works, Inc. ("Creevy Bala") admits the allegations in Count I of the Complaint in this matter;
- 2. Pursuant to Count I, Creevy Bala agrees that it owes Harold O. Schulz Company, Inc. ("HOS") the amount of \$47,945,00;
 - 3. Further, Creevy Bala agrees that it owes HOS:
 - Interest on \$9250.00 of the total amount due (347.945.00) at a rate of 5% per annum pursuant to 815 ILCS 205/1 as of as of December 19, 2019, for a total of \$674.48 as of today's date;
 - Interest on \$38,695.00 the amount due (\$47,945.00) at a rate of 5% per annum pursuant to 815 ILCS 205/1 as of October 30, 2019 for a total case 3869.50 as of today's date; and
 - Attorney fees and costs incurred in bringing this action, in the amount of \$18,869.44;
- 4. Based on the above, Creevy Bala consents to judgment being entered in this matter against it on Count I of the Complaint, in the amount of \$71,358.42;
- 5. Accordingly, this Court enters judgment against Creevy Bala Investments, LLC d/b/a D&D Natural Stone Works, Inc. and in favor of Harold O. Schulz Company, Inc. on Count I of the Complaint in the amount of \$71,358.42;
- 6. Count II of the Complaint is hereby dismissed. The remaining Counts in the Complaint, Counts III and IV, are against Connor Creevy, individually, and will have no bearing on the appealability or enforcement of the judgment entered against Creevy Bala Investments, LLC d/b/a D&D Natural Stone Works, Inc.;

- 7. As this is an agreed judgment, there is minimal risk of multiple appeals if this is a final, appealable, and enforceable order.

Pursuant to Illinois Supreme Court Rule 304(a), the Court finds that there is no just reason for delaying either enforcement or appeal or both of this order.
