TO HAVE AND HOLD said premises with the appurtenances, upon the trusts, and for the uses and purposes set forth herein and in the Trust Agreement.

or in the future, and upon any terms and for any period or periods of time, not exceeding in the case of any single demise the term of 198 years; renew or extend leases upon any terms and for any period or periods of time and to amend, change, or modify leases and the terms and provisions thereof at any time or times hereafter; contract to make leases, grant options to lease, options to renew leases, and options to purchase the whole or any part of the reversion; contract with respect to fixing the amount of present or future rentals; partition or exchange the Property for other real or personal property; grant easements or charges of any kind, to release, convey, or assign any right or title or interest in or about or easement appurtenant to the Property or any part thereof; enter into contracts or other agreements containing provisions exculpating the Trustee from personal liability; and deal with the Property and every part thereof in all other ways and for such other considerations as it would be lawful for any person owning the same to deal with the same, whether similar to or different from the ways above specified at any time or times hereafter.

Every deed, trust deed, mortgage, lease, or other assignment, instrument, or document executed by the Trustee in relation to the Property shall be conclusive evidence in favor of every person relying upon or claiming under any such conveyance, lease, or other instrument, (a) that at the time of the delivery thereof the trusts created by this Indenture and by the Trust Agreement were in full force and effect, (b) that such conveyance or other instrumen was executed in accordance with the trusts, conditions, and limitations contained in this Indenure and in the Trust Agreement or in some amendments thereof and binding upon all beneficiaries (recreated, (c) that the Trustee was duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage, or other assignment, instrument, or document, and (d), if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have from properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties, and obligations of their predecessors in trust.
