Unit No. 2F as delineated on survey of the following described parcel of real estate (hereinafter referred to as "Parcel"): Lots 15, 16, 17, 18 and 19 in Block 6 in Edison Park, a Subdivision in Section 36, Township 41 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, which survey is attached as Exhibit "A" to Declaration made by Northwest National Bank as Trustee under Trust No. 2832 recorded in the Office of the Recorder of Cook County, Illinois as Document No. 23291719; together with an undivided 5% interest in said Parcel (excepting from said Parcel all the property and space comprising all the units thereof as defined and set forth in said Declaration and survey).

Party of the first part also hereby grants to parties of the second part, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and party of the first part reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.
