If the Authority does not securitize or purchase the Security Instrument and the Note, or if the Authority sells or otherwise transfers 'the Security Instrument and the Note to another individual or entity, the provisions of this Rider shall no longer apply or be effective, and this Rider shall be detached from the Security Instrument.
