ORDER

THIS CAUSE COMING TO BE HEARD on the continued hearing for Ronald Wright's Motion for a Preliminary Injunction and Calumet City's Verified Emergency Motion for Temporary Restraining Order and Preliminary Injunction, due notice having been given and the Court being fully advised in the premises:

IT IS HEREBY ORDERED:

1. This matter is continued to April 3, 2023 at 10:00 a.m., which will be conducted via Zoom with meeting ID 955 3557 3920 (no password required).
2. Calumet City ("the City") shall not lock 1607 Sibley Boulevard or 463 Oglesby, Calumet City, Illinois until further order of this court or any other court hearing this matter.

3. The City shall return Ronald Wright's 2000 Chevrolet pick-up and a 2007 Ford Crown Victoria. If Mr. Ronald Wright picks up the 2 vehicles within 7 days, by February 16, 2023, the City has agreed that any fees charged will be waived. If Mr. Wright fails to pick up the 2 vehicles by February 16, 2023, then the fees shall be required.
4. Mr. Wright is ordered to allow access to 1607 Sibley Boulevard property to the City to determine what if any damage was caused to the building windows.
5. The City shall return any personal items taken from, if any, the interior of 1607 Sibley Boulevard, Calumet City, Illinois was performed.
6. This Court denies the City's Motion for a Temporary Restraining Order, finding that no emergency has been stated. The City's Motion for a Preliminary Injunction is entered and continued.
7. Plaintiff and Defendant will discuss any barriers on the driveway of 1607 Sibley Boulevard as well as the garage prior to the next court date.

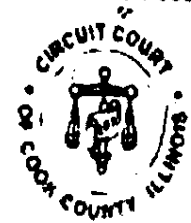
