IT IS HEREBY ORDERED:



- 3. The City shall return Ronald Wright's 2000 Chevrolet pick-up and a 2007 Ford Crown Victoria. If Mr. Ronald Wright picks up the 2 vehicles within 7 days, by February 16, 2023, the City has agreed that any fees charged will be waived. If Mr. Wright fails to pick up the 2 vehicles by February 16, 2023, then the fees shall be required.
- 4. Mr. Wright is ordered to allow access to 1607 Sibley Boulevard property to the City to determine what if any damage was caused to the building windows.
- 5. The City shall return any personal items taken from, if any, the interior of 1607 Sibley Boulevard, Calumet City, Illinois was performed.
