- 5. There is now justly due and owing the Claimant after allowing to the Owner(s) all credits deductions and offsets, the sum of \$4,640.78 plus interest at the rate specified in the Illinois Mechanics Lien Act.
- 6. Claimant now claims a lien on the above-described Property, and on all of the improvements the reo.), against the Owner(s) and all persons interested at the rate specified in the illinois Mechanics Lien Act, as well as court costs and attorneys fees.
