RIDER TO DEED FOR BROOKSIDE CONDOMINIUM

Grantor also hereby grants to Grantee, their successors and assigns, as an easement appurtenant to the land herein conveyed, a perpetual, exclusive easement for parking purposes in and to parking area No. G-605.4 as defined and set forth in said Declaration and Survey.
