Gladys, Chicago, Illinois. IN COOK COUNTY, ILLINOIS

TO have and to hold the same, with all the appurtenances thereto belonging to the said Plaintiff, EMMA STRONG, her heirs and assigns forever.

THIS deed is executed and delivered solely in compliance with the Judgment for Divorce herein above referred to.
