This Indenture, Made this 31st day of March 1978

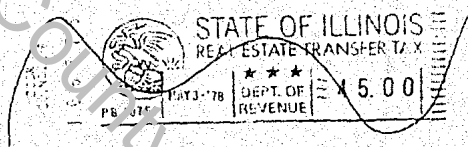

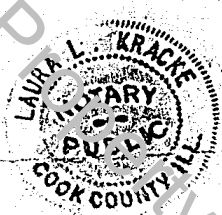
