Mortgagers shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanic's or other here or claims for lie not expersely subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a hen or charge of the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the dasharge of such prior then to Trustee or to holders of the note; (d) complete within a reasonable time any building or buildings now or at any time in process of exection upon usul premises; (e) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (1) make no material alterations in said premises except as required by law or municipal ordinance.

2.
