The Trustee or the holders of the note he by secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.

 6. Mortgagors shall pay each item of indebte ness here in mentioned, both principal and interest, when due according to the terms hereof. At the election of the holders of the principal note, and will not into the contrary, become due and payable when default shall occur in payment of principal or interest, or in case default shall occur and continued.

When the indebtedness hereby secured shall become due whether by the terms of the note described on page one or by acceleration or otherwise, holders of the note or Trustee shall have the right to "ce" et he lien hereof and also shall have all other rights provided by the laws of Illinois for the enforcement of a mortgage debt. In any suit to freel se the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses whith in ry be paid or incurred by or on behalf of Trustee or holders of the note for attorneys' fees. Trustee's fees, appraiser's fees, outlays for document, y and expert evidence, stenographers' charges, publication costs and costs (which may be estimated as to items to be expended after entry of the letter 1) for procuring all such abstracts of title, title searches and examinations, guarantee policies. Torrens certificates, and similar data and assulance with respect to title as Trustee or holders of the note may deem to be reasonably necessary either to prosecute such suit or to evidence to bidde. The procuring all such abstracts of title, title searches and examinations of the title to or the value of the premises. Such appointment may be made either before or after sale, without notice, with ut regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the abundance of the property of the solvency of Mortgagors at the time of application for such receiver and without regard to the then value of the property of the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver. Such review shall we power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deciency during the full statutory period for redemption, whether there be redemption or not, as well as during any further times when Mortgag ris, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be nece sary or the usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. "C cut from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of: (1) The indebtedne served thereby, or by any decree foreclosing this Trust Deed, or any tax, special assessment or other lien which may be or become superior to the ine hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale and deficiency.
- 10. No action for the enforcement of the lien of this Trust Deed or of any provision hereof shall be subject to any d'.ens/ which would not good and available to the party interposing same in an action at law upon the note hereby secured.
