JAMES M. BROWN and BARBARA A. BROWN, GRANTEES

Unit 411 A in the Flagg Creek Condominium as delineated on survey of part of the North West 1/4 of Section 29, Township 38 North, Range 12 East of the Third Principal New Part 1 ian, in Cook County, Illinois (hereinafter referred to as Parcel), which survey is attached as exhibit "A" to declaration of condominium made by American National Bank and Tract Company of Chicago, Trust Number 38035 recorded in the Office of the Recorder of Deeds of Cook County, Illinois, as Pocument No. 23676217 as amended from time to time; together with its undivided percentage of interest in said parcel electing from said parcel all the property and space comprising all the units thereof as defined and set forth in said Declaration and survey).

This deed is conveyed on the conditional limitation that the percentage of ownership of said grantees in the common elements shall be divided pro tanto and vest in the grantees of the other units in accordance with the terms of said declaration and any amenied declarations recorded pursuant hereto, and the right of revocation is also hereby reserved to the grantor herein to accomplish this result. The acceptance of this conveyance by the grantees shall be deemed an agreement within the contemplation of the Condominium Property Act of the State of Ilinois to a shifting of the common elements pursuant to said declaration and to all other terms of said declaration, which in hereby incorporated herein by reference thereto, and to all the terms of each amended declaration recorded pursuant thereco.

Grantor also hereby grants to Grantee, its successors and assigns, as rights and easements appurtenent to the above described real estate, the rights and easements for the benefit of said property set forth in the efformentioned declaration.

This Deed is subject to all rights, easements, restrictions and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.
