The acceptance of this convavance by the Grantees shall be deemed an agreement within the contemplation of the Condominium Property Act of the State of Illinois to a snifting of the Common Elements pursuant to said Declaration and to all the other terms of said Declaration, which is hereby incorporated herein by reference thereto, and to all the terms of each Amended Declaration recorded pursuant thereto.

Grantor also hereby grants to Mount Prospect State Bank as Pristee under Trust No. 775 and not to the above described real estate, the rights and easements appurlement and the Grantor reserves to itself, its successors and assigns the rights and easements set forth in the aforementioned Declaration, rights and easements set forth in said Declaration for the benefit of the remaining property described therein.
