SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

1. Mortgagors shall (1) keep said premites in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may be some changed or be destroyed; (3) keep said premises free from mechanic's liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or change or the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to correction or to holders of the note; (5) complete within a reasonable time any buildings on buildings now or at any time in process of creation open said premises; (6) complete within a reasonable time any buildings now or at any time in process of creation open and premises; (6) complete within a reasonable time any buildings now or at any time in process of creation open said premises; (6) complete within a reasonable time any buildings now or at any time in process of creation open said premises; (6) complete within a reasonable time any buildings now or at any time in process of creation open said premises; (6) complete within a read premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
