- THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

 1. Mortgagors shall: (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or ba destroyed; (2) keep said premises in good condition and repair, without waste, and free-from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereot; (3) pay to hereol, and upon requeste skhiblt satisfactory evidence of the disease per success or lien or lien to Trustee or to holders of the note; (4) complete within a reasonable time any building or buildings now or at any time in process or erection upon said premises except as required by law or municipal ordinances with respect to the premises and the use thereot; (5) make no material alterations and premises except as required by law or municipal ordinances.

 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, (and other charges) against the premises when due, and shall, upon written request, furnish to the holders of the note duplicate receipts therefore. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided in statute, any tax or assessment which Mortgagors may desire to contest.

 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on sinured against loss or damage by fire, lightening or vindstorm and such other hazards or liability, including liquor liability as the holders of the note may require under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to any in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by th
