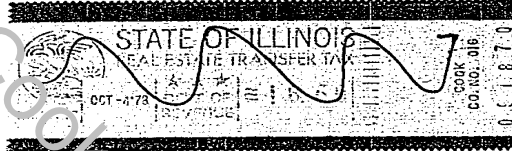


Trustee's Deed Joint Tenancy 24 656 411

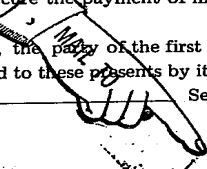
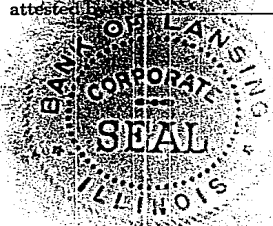
