THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanic's liters or liens in favor of the United States or other liens or claims for lien ot expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) complete within a reasonable time any buildings now or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material altertations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charge service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of i the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner prov statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of innoneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies usinfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in ease of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or scute any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized all expenses paid or incurred in connection therewith, including reasonable attorneys fees, and any other moneys advanced by Trustee or the hoders of the note to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action herein authorized may be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and without notice and with interest thereon at the rate of seven per cent per annum. Inaction of Trustee or holders of the note shall never be convicted as a waiver of any right accruing to them on account of any default hereunder on the part of Mortgagors.
- 5. The Trustee or the holders of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according, any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or eximite or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
- 6. Mor sugers shall pay each item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. - 9. Upon or at any time after the filing of a complaint to fore does this Trust Deed, the Court in which such complaint is filed may appoint a receiver of said premises. Trustee has no duty to examine the title, location, existence, or condition of the premies, no shall Trustee be obligated to record this Trust Deed or to exercise any power herein given unless expressly obligated by the terms hereout not not be liable for any acts or omissions hereunder, except in case of his own gross negligence or misconduct or that of the agents or employee, of Trustee, and he may require indemnities satisfactory to him before exercising any power herein given.
