This Indenture, Made this 10th day of August A. D. 19 78,

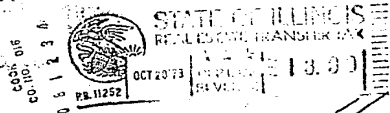

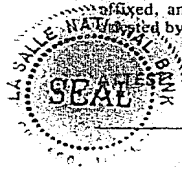
