THIS INDENTURE WITNESSETH, that INDIANA HARBOR BELT RAILROAD COMPANY, a corporation of the State of Indiana, hereinafter referred to as the "Grantor", for and in consideration of Eight Thousand Five Hundred collars (\$8,500.00) and pursuant to the authority given by the Foa d of Directors of the Indiana Harbor Belt Railroad Company, the said Grantor conveys and quitclaims unto CHICAGO TUBE AND IRON COMPANY, a corporation of the State of Illinois, whose mailing address is 2551 West 48th Street, Chicago, Illinois 60632, hereinafter referred to as the "Grantee", all its right, title and interest of, in and to

ALL THAT CERTAIN strip or parcel of land, together with any track and appurtenances located thereon, situate in the City of Chicago, County of Cook and State of Illinois, bounded and described in accordance with a survey of Jerome Kennedy, Illinois Land Surveyor (Order No. 7412-017, Book 1305 rage 110 L/L) and Plat of Survey by Emmet Kennedy & Co., Surveyors - Engineers, dated December 31, 1974, being a strip of land 18 feet in width, being that part of Lot A of Resubdivision of Block 5 in William D. Kerfoot and Co.'s 51st Street Addition, being a subdivision of Southwest Quarter (except North 133 feet thereof) of Northeast Quarter of Section 12, Township 38 North, Range 13 East of Third Principal Meridian, described as follows:

COMMENCING at a point on a line drawn parallel with and 125 feet east of West line of said Lot A, said point being 207 feet North of South line of said Lot A, and running thence North along said parallel line a distance of 18 feet, thence east para with said South line of Lot A, a distance of 71.68 feet; thence Northeasterly on a curved line convexed Southeasterly, tangent said parallel line and having a radius of 310.62 feet, a distant of 194.73 feet (arc), thence Northeasterly on a straight line, tangent to said curved line, a distance of 134.43 feet; thence Northeasterly on a curved line, convexed Northwesterly, tangent to last described straight line and having a radius of 1040.22 feet, a distance of 58.76 feet (arc) to an intersection with

following leacribed line (being the Southerly line of right of way conveyed to the Indiana Harbor Belt Railroad Company, and recorded in Recorder's Office of Cook County, Illinois, on June 6, 1932 as Document No. 1,098347);

COMMENCING at a poin: on a line drawn parallel with and 66 feet south of North line of Lot A aforesaid, said point being 888.72 feet West of East line of said Lot A; and running thence Southeasterly on a straight line forming an angle of 6° 22' with said parallel line, a distance of 25.02 feet; thence Southeasterly on a curved line convexed northeasterly, tangent to last described straight line and having a radius of 373 06 feet a distance of 67.28 feet (arc); thence Southeasterly on a straight line tangent to said curved line, a distance of 70.87 feet to said intersection,

THENCE continuing southeasterly, along last described straight line a distance of 23.86 feet; thence Southwesterly or a curved line convexed northwesterly, having a radius of 1022.20 foot and concentric with said curved line 58.76 feet long, a distance of 73.27 feet (arc); thence Southwesterly on a straight line targent to last described curved line, a distance of 134.43 feet; thence Southwesterly on a curved line, convexed southeasterly, tangent with last described straight line and having a radius of 328.62 feet, a distance of 206.02 feet (arc) to a point of tangency with a line drawn parallel with and 207 feet north of said South line of Lot A; thence West along said parallel line a distance of 71.71 feet to point of beginning.

SUBJECT, however, to any easements or agreements of record, any easements which may be disclosed on the aforementioned survey plan and to any other pipes, wires, poles, cables, culverts, drainage courses or systems and their appurtenances now existing and remaining in, on, under, over and through the premises conveyed by this indenture and any rights to use, maintain, repair, renew and remove same.

understanding and agreement:

(a) that a right or means of ingress, egress or passageway to or from the Land hereinbefore described is not hereby granted, specifically or by implication, and that Grantor shall not and will not be liable or collect to obtain for Grantee such means of ingress, egress or passageway and that Grantee will obtain a means of access to and from the said strip or parcel of land hereinbefore described over Grantee's property of at Grantee's sole cost and expense;

- (b) that Grantor shall not be liable or obligated to construct or maintain any fence between the 1...d hereinbefore described and land of Grantor adjoining the same: or be liable or obligated to pay for any part of the cost or expense of constructing or maintaining such a fence or any part thereof or be liable for any compensation for any damage that may result by reason of the non-existence of such a fence;
- (c) that should a claim adverse to the title hereby quitclaimed be asserted and/or proved, no recourse shall be had against the said Grantor.

THE words "Grantor" and "Grantee" used herein shall be construed as if they read "Grantors" and "Grantees", respectively, whenever the sense of this indenture so requires and whether singular or plural, such words shall be deemed to include in all cases the heirs or successors and assigns of the respective parties.


