Grantor hereby grants to Grantee, their successors and assigns, as rights and easements appurituant to the above described real estate, the rights and easements it the benefit of said property set forth in the aforementioned Delication of Condominium, and Grantor reserves to itself, its successors and assigns the rights and easements set forth in said Declarations for the benefit of the remaining property described therein.
