The Tenant, if any, of this Unit, has either waived or has failed to exercise his right of first refusal to purchase this unit or had no such right of first refusal, pursuant to Chapter 100.1 of the Municipal Code of Chicago and the provisions of the Illinois Condominium Property Act.
