THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanic's liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of note, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver rank and in case of insurance about to expire, shall deliver renewal policies, including additional and renewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including reasonable attorneys' fees, and any other moneys advanced by Trustee or the holders of the note to protect the mortgaged premises and the lien hereof, pulse reasonable compensation to Trustee for each matter concerning which action herein authorized may be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and the contraction of the part of the par
- 5. The Trustee or the holders of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so acc; ding to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or a mate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
- 6. Mortgagors shall pay each item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the electif a c the holders of the principal note, and without notice to Mortgagors, all unpaid indebtedness secured by this Trust Deed shall, notwithstan ing; any ing in the principal note or in this Trust Deed to the contrary, become due and payable when default shall occur in payment of principal r i et st, or in case default shall occur and continue for three days in the performance of any other agreement of the Mortgagors herein contained.
- 7. When the inde'.cm, ss hereby secured shall become due whether by the terms of the note described on page one or by acceleration or otherwise, holders of it e note or Trustee shall have the right to foreclose the lien hereof and also shall have all other rights provided by the laws of Illinois for the enfe cemen of a mortgage debt. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decr. For sale all expenditures and expenses which may be paid or incred by or on behalf of Trustee or holders of the note for attorneys' fees, Trustee's, .ce; ap raiser's fees, outlays for documentary and expert evidence, stenographers' charges, publication costs and costs (which may be estimated as to it in so be expended after entry of the decree) of procuring all such abstracts of title, little searches and examinations, guarantee policies, To: er c''licates, and similar data and assurances which may be had pursuant to such decree the true condomes on such additional indebtes. - 8. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure and expenses incident to the foreclosure and edge, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof onst ute secured indebtedness additional to that evidenced by the note hereby secured, with interest thereon as herein provided; third, all principally and principally an expense.

(regard to then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver. - 11. Trustee or the holders of the note shall have the right to inspect the promises all reasonable times and access thereto shall be permitted for that purpose.
- 12. Trustee has no duty to examine the title, location, existence, or condition of the _______cer, nor shall Trustee be obligated to record this Trust Deed or to exercise any power herein given unless expressly obligated by the er as hereof, nor be liable for any acts or omissions hereunder, except in case of his own gross negligence or misconduct or that of the agents or er ploy _ of Trustee, and he may require indemnities satisfactory to him before exercising any nower herein given.
- 13. Trustee shall release this Trust Deed and the lien thereof by proper instrument upon p intation of satisfactory evidence that all indebteness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a rele—the coff to and at the request of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal lote, presenting that all indebtedness hereby secured has been paid, which representation Trustee may accept as true without inquiry. Where a i lease i requested of a successor trustee such successor trustee may accept as the genuine note herein described any note which bears a certificate of ier Caution proprint to be executed by a prior trustee hereunder or which conforms in substance with the description herein contained.
