EXHIBIT A

LEGAL DESCRIPTION ATTACHED TO DEED DATED APRIL 24, 1978 FROM OKLAHOMA OIL CO. TO LEONARD GUNCHICK

That part of the West 10.5 acres of the South 1/4 of the East 1/2 of the South West 1/4 of Section 26, Township 41 North, Range 13 East of the Third Principal Meridian described as follows:
Beginning at a point on the center line of North Hamlin Avenue, being the West line of said 10.5 acres 157 feet North of the center line of Touhy Avenue, being the South line of said South West 1/4; running thence East and parallel with the center line of said Touhy Avenue 330 feet; thence South on a line parallel with the West line of said West 10.5 acres 157 feet to the center line of said Touhy Avenue; thence West on the center line of said Touhy Avenue 330 feet to the center line of said North Lamlin Avenue; thence North 157 feet to the point of beguning (except therefrom the South 33 feet; the West 33 feet ar 1 the East 33 feet thereof) in Cook County, Illinois.
