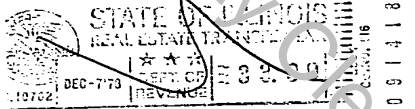

 following described real estate situated in Cook county, Illinois, to-wit:

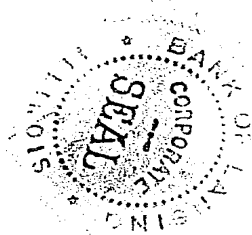
Lots 66 and 67 in Country Corners First Addition, being a

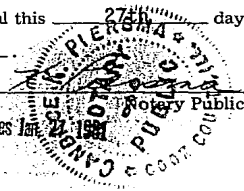
