1. 11. Trustee or the holders of the note shall have the right to inspect the premises at all reasonable times and access the oshall be permitted for that purpose.

Trustee shall release this trust deed and the lien thereof by proper instrument upon presentation of satisfactory evidence that first before or after maturity thereof, produce and exhibit to Trustee the note, representing that all indebtedness hereby secured has been fully paid; and Trustee may execute and deliver a release hereof to and at the request of any person whe shall, the presentation Trustee may accept as true without inquiry. Where a release is requested of a successor trustee, such successor trustee may accept as the described any note which bears an identification number purporting to be placed thereon by a prior trustee hereunder or which commission and the release is requested by the persons herein designated as the nake, thereof; and where the release is requested of the original trustee and hich purports to be executed by the persons herein designated as the nake.

14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed.
