SUBJECT TO: General real estate taxes for the year 1978 and subsequent years.

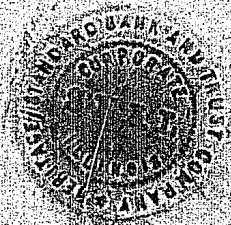
